Banner Battle

Congress Told of Damage Done by Union Campaign

local contractor told a congressional hearing in Washington, D.C., on Thursday that a "Shame On" bannering campaign by an Los Angeles carpenters union over the past few years has cost him \$100,000 in business, tens of thousands of dollars in legal fees and forced layoffs.

Chet Karnas, president and owner of Lone Sun Builders Inc. told the U.S. House Education and the Workforce Committee's Subcommittee on Health, Employment, Labor and Pensions that the union campaign has hurt his company's reputation, caused a 20 to 30 percent drop in sales and is partly to blame, along with the economy, for "a tremendous amount of layoffs."

That's despite an effort by Lone Sun Builders Inc. to fight back, including staging counter-protests against the

union and publishing a blog.
"Despite our efforts, business has still suffered. Many clients were

impacted and many general contractors are reluctant to utilize our services fearing the organizer's aggressive presence," he told the committee, which streamed the hearing live online.

Karmas, one of four witnesses speaking Thursday, said the bannering against his company by the Los Angeles-based Southwest Regional Council of Carpenters began in 2008 at about a dozen work sites.

"The carpenters (union) displayed these large signs in front of our client's buildings emblazoned with inflammatory, unfounded claims about our labor policies," he said.

The campaign escalated in 2009 to mass pickets that included vulgar chants, false accusations, physical threats, trespassing and more, he said. In one incident, police were called during a union protest at St. Michael & All Angels Episcopal Church in the North Valley.

The Southwest Regional Council of Carpenters, which has organized numerous bannerings around Albuquerque and Santa Fe using Carpenters Local 1319 on its signs, has yet to provide details to the **Journal** about the protests and how sites are chosen despite years of requests for comment.

Typically, a few hired non-union workers hand out fliers and hold up a white banner reading "Shame On" with the name of a particular business following it and "labor dispute" in black lettering on two top areas of the banner.
